#### Chichester Local Plan: Key Policies 2014 - 2029

The Chichester Local Plan: Key Policies 2014-2029 has been adopted after being examined by an Inspector, and Southbourne Parish has to provide 350 new dwellings - 300 in Southbourne and 50 elsewhere in the Parish.

#### Southbourne Parish Neighbourhood Plan

During the last two years residents have been asked how you want your community to develop? What type of Houses? Where? What new facilities are needed?

We have tried to fit the Plan to your views.

THE NEIGHBOURHOOD PLAN HAS HELPED PROVIDE NEW SITES FOR 350 NEW HOUSES IN SOUTHBOURNE.

AFTER 3 YEARS OF HARD WORK, INCLUDING OVER 2 YEARS LISTENING TO THE LOCAL COMMUNITY AND THEIR VISION FOR SOUTHBOURNE, THE STATUTORY PROCESSES HAVE NOW BEEN COMPLETED. THE PLAN HAS BEEN PREPARED, INSPECTED AND VERIFIED. IT IS NOW UP TO YOU, THE PEOPLE OF SOUTHBOURNE TO VOTE ON IT.

#### Already the Neighbourhood Plan has achieved:

#### Housing

- Four sites found for the required 350 dwellings all south of the railway crossing.
- Permitted 177 dwellings on two of the Plan sites in Southbourne, 70 of these are reserved for local people on the housing lists. An application is now in for 125 more on the third site. 50 dwellings on the Plan site in Nutbourne are in the pipeline. All are south of the railway crossings.
- Refused Over 370 dwellings have already been refused or applications withdrawn on six other sites. NOT in the Plan, five are north of the railway. With the help of the Plan, these sites have been firmly resisted by the District and Parish Council assisted by hundreds of letters from residents. (One appeal has been dismissed and two withdrawn). Without a Plan it would be more difficult to resist speculative planning applications.









#### Local Services



 About one and a half million pounds will come from the two permissions already granted for local facilities, of which nearly £700,000 will go to our schools.

#### Green Ring



 The first new sections of the Green Ring are included in the two approved sites, as is space for one leg of a railway footbridge. The Parish Council is being helped by a government agency to explore how to achieve more.

#### The Road



 The permission at Gosden Green provides space for a new western road. The current application north of Alfrey Close proposes safeguarding the rest of the route up to the railway. It's a start!

#### Flooding



 Flooding on the A259 Main Road at Stein Road, Gosden Green and Nutbourne has been relieved through the determined efforts of Plan volunteers working with landowners/ developers and the District and County Councils.

A Referendum will be held on Thursday, 5th November 2015 to decide on the following question:

"Do you want Chichester District Council to use the neighbourhood plan for Southbourne to help it decide planning applications in the neighbourhood area?"
